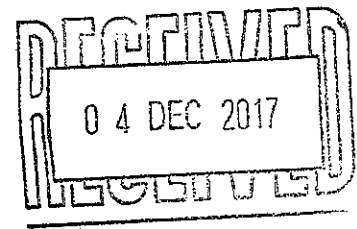

## Selection and Confirmation

- Successful applicants must return duly completed and signed acceptance form by the deadline to confirm their participation in the programme.
